Kathy thanked Mark and Shirley Rippy for joining the PTC. She said their commitments and service to Starke County had already been well established.

Diane Blais moved moved to approve the Treasurer's Report and the Report of Restricted and Unrestricted Funds. Paul seconded the motion, and the motion carried.

"North Judson Celebrate Trails Day April 22, 2023" Final Preparations

A workgroup met twice at Rich Vallicelli's home to help formulate plans for the PTC's role in the North Judson version of "Celebrate Trails Day April 22, 2023", a "signature event" of the Rails-to-Trails Conservancy. These meetings were supported by numerous phone calls, texts, and email messages among the workgroup and with the Conservancy. Final preparations for the event were made during the meeting by the membership as a whole.

Northwest Trail Extension Workgroup Report

The DNR's Division of State Parks is reviewing the PTC's application for an Indiana Trails Program (ITP) grant to determine whether the application achieves technical compliance. The agency sought clarification regarding credit sought for the easement valuation, and regarding steps the PTC would take for the protection of a rare plant (commonly called

"Leiberg's witchgrass"), which has been documented in the project area, if the grant is issued. The PTC has responded to the requests for clarification and is awaiting DNR's reply.

Maintenance Workgroup Report

On March 17 (St.Patrick's Day), Paul, Larry Wickert, Russ Blais and Steve Lucas met with Nick Cohen, CEO of Doral Renewables, LLC, and members of his staff, at the Fell Ditch bridge. Previously, Larry had requested funding from Mammoth Solar, a subsidiary of Doral Renewables. The funding would assist with rehabilitation of the bridge, as well as with vegetation control for areas along the trail east of Range Road. The onsite meeting was cordial and encouraging, but no final decisions were made.







Paul developed an agreement with a local farmer to have brush removed along the trail in the vicinity of Fell Ditch. Work completed in mid-March illustrated how the PTC could benefit from Doral funding for brush removal on other parts of the trail.

Informal Review of HVRM Activities

Bob Albert, Hoosier Valley Railroad Museum Liaison to the PTC, reported upon the great success of the Easter Trains. Ten thousand eggs were distributed from hunts among 1,100 riders. He said regular Saturday train rides resume on May 6. No special events are planned for that day. He also reported the Northern Indiana Railroad has been sold.

Wayfinding Signage

As anticipated in our March meeting, Yancy Lucas prepared high-resolution proofs for all eight of the wayfinding (you-are-here type) signs needed to either replace obsolete or supplement existing signs. Proofs for the signs were sent electronically to OTES Signs & Graphics, and on April 10 OTES stated it would place them in production.

Riley 5K Run

PTC member, Kevin Kennedy, passed along that Peru schools are hosting the Riley Run on Saturday, May 13, beginning at 8:00 a.m., CDT (9:00 a.m., EDT) at 907 West Main Street, Peru, with tickets starting at \$25. The event is a 5K Walk/Run to raise money for Riley Children's Hospital in Indianapolis.

Trail Counters Update

Joan Hardesty provided an update on data collected at the PTC's two trail counters on the eastern portion of the Erie Trail. She circulated printouts documenting recent trail usage.
